The Fraternal year is proceeding as you have planned, I trust, and while the year is not over it is time to reflect and choose the activities you want to showcase. Our Wyoming Councils have been as active and vibrant this year as of any of the last 100 years that Wyoming has had Knight of Columbus Councils. It is truly exciting to be part of a Brotherhood in which we share common beliefs and excitement for our Faith. We do this through our Council activities based in our Faith in Action.

The Faith in Action program sections have given you a guide for using and demonstrating those time-honored gifts of Charity, Unity and Fraternity. First and foremost, the Council completed activities needs to be told in the reports you submit for the Columbian Awards Application (#SP-7). You will find that form and the others that I will reference throughout this letter listed below.

You now also have the opportunity to submit your Council's activities to the State for consideration for the State Awards. As you fill out those award forms, use the **FAITH IN ACTION guidebook** from the Supreme website as a guide. The **Fraternal Programs Report Form** will also help guide you through the process.

Once you have completed that process, please do us the honor of submitting your single best program or activity **in each of the four (4) categories: Faith, Family, Community, and Life** to the State Council for judging **before** the Wyoming State Convention being held in Lander, April 25th through the 27th.

Award nominations are due to April 11th!

The Form **State Council Service Program Awards Entry Form (#STSP)** is the proper way to submit each of these entries for four categories. You are also encouraged to submit **Wyoming State Family of the Year (form #10680)** and the **Wyoming State Knight of the Year** (no form as it is a State Program). The links for the forms are listed below.

For the 3rd straight year the Knights are accepting the **State Blessed Michael McGivney Award** (form #SBMMA). A matter of courtesy and protocol it would probably be best to obtain the Priest's permission to nominate him.

We need to have the entries in early to judge the **Faith, Family, Community and Life** entries plus the **Wyoming State Family of the Year** and the **Wyoming State Knight of the Year**.

The Past State Deputies will conduct an on-line review and judging as we did last year. We found that the ability to see, read, and review the submissions with more time was beneficial. In the past when having to do these on an early Friday morning, many times we ran into and over some of the opening ceremonies at the Convention. Please note again the due date is April 11th.

RE: 2024 Tax Information for KofC Councils, Assemblies, & Chapters

This notice is to remind councils, assemblies, and chapters in the United States of their legal obligation to file an IRS Form 990 (informational tax return) for the 2024 tax year, and to provide detailed instructions on how to comply with this obligation.

The Knights of Columbus, including all subordinate councils, assemblies, and chapters (collectively referred to as councils), is a tax-exempt organization, recognized by the Internal Revenue Service as a fraternal benefit society under Section 501(c)(8) of the Internal Revenue Code. This tax-exempt status requires each council to file an annual Form 990 with the IRS.

Councils reporting gross receipts of \$50,000 or less with less than \$200,000 in assets may comply with their obligation by filing the Form 990-N electronic postcard (also known as the e- Postcard). Councils reporting gross receipts of more than \$50,000 and less than \$200,000 with total assets of less than \$500,000 must file the Form 990-EZ. Councils with gross receipts of \$200,000 or more and total assets of \$500,000 or more must file the Form 990.

REMINDER

The IRS requires electronic filing for **all** tax-exempt organizations, regardless of which form they use. The online filing system, also known as “E-Services”, requires **all new users** to register or sign in with LOGIN.GOV or ID.me, the current IRS credential service providers.

There are two ways to access the Form 990-N Electronic Filing system: (1) Sign in with your active IRS username; or (2) Sign in/ create an account with [LOGIN.GOV](https://www.login.gov) or [ID.me](https://www.id.me). Form 990-N filers who have an existing IRS username and register for a new Login.gov or ID.me account must use the email address associated with their IRS account. Refer to User Guide for the IRS Form 990-N Electronic Filing System. Instructions are available on the IRS website, links to which are in the *Where to File* section, below.

During this tax season, we would like to remind you to beware of scams and fraud. The IRS has published information on how to identify scams and fraud and what you can do to protect yourself. [**Recognize tax scams and fraud | Internal Revenue Service**](#)

Deadline to file annual return (all forms)

Each council must file its own tax return; there is no group or consolidated Form 990 filing. The returns must be filed by the fifteenth day of the fifth month following the end of the council's annual accounting period. For example, if a council's accounting period ends December 31, it must file a tax return by May 15 of the following year; if a council's accounting period ends June 30, it must file a tax return by November 15. Please note that **the IRS assigns the accounting period to each council based on its Employer Identification Number (EIN)**. The IRS **will not** notify the council of the accounting period. To determine the accounting period assigned to your council's EIN, sign into the IRS system with your user ID and password. For most councils, the assigned accounting period corresponds to the calendar year.



Need more time to file a Form 990?

Although the IRS does not grant extensions for filing the Form 990-N (e-Postcard), the IRS will accept late filings if the tax return is received within three years of the due date. While the IRS will accept late filings of Form 990-N (e-Postcard), please note that filing late, even within a three-year period, is still considered a missed filing by the IRS and may trigger a revocation of a council's tax-exempt status if for three consecutive years the council files late or fails to file a return. The IRS does grant extensions to organizations filing Forms 990-EZ and 990. If a council needs more time to file the Form 990-EZ or 990, it must request an extension by the due date of the return for which it is requesting an extension. Federal law imposes a penalty for late or incomplete filings. If an organization fails to file a required return by the due date (including any extension of time), it must pay a penalty of \$25 a day for each day the return is late. In general, the maximum penalty for any late return is the lesser of \$12,500 or five percent of the organization's gross receipts for the year. In order to request an extension, councils must submit Form 8868, which is available on the IRS website: <http://www.irs.gov/pub/irs-pdf/f8868.pdf>. For councils reporting gross receipts of more than \$50,000, we recommend using a qualified tax professional to file Form 8868.

Where to file

Form 990-N (e-Postcard)

The Form 990-N (e-Postcard) must be filed online.

The Knights of Columbus Form 990-N e-postcard filing instructions are located on Officers Online (go to Officers' Desk Reference, Tax Issues, #6 Federal Tax Returns).

If you use the above link to file the Form 990N (e-Postcard) there is no filing fee, as it connects directly to IRS.gov.

Forms 990-EZ and 990

Forms 990-EZ and 990 must be filed online. The IRS website provides instructions for electronic filing of Forms 990-EZ and 990: <https://www.irs.gov/charities-non-profits/current-form-990-series-forms-and-instructions>

Any council reporting gross receipts of more than \$50,000 is strongly urged to consider using a qualified tax professional to prepare and file its tax return.

PRACTICE TIPS:

When filing, bear in mind that text fields cannot exceed 35 characters and must contain only numeric, alpha or hyphen characters. Periods, slashes and so on will cause filing errors.

At the top of the Form 990-EZ and Form 990, enter the Knights of Columbus group number (0188), tax exempt status (Section 501(c)(8)), and form of organization (Association). You may find e-filing instructions for the Form 990-N e-Postcard here: <https://www.irs.gov/e-file-providers/e-file-for-charities-and-non-profits>

If the IRS website will not allow you to file a Form 990-N

The electronic filing system for the Form 990-N (e-Postcard) may reject a council's return if: (1) the council's EIN has been revoked for failing to file for three consecutive years; (2) the council's EIN has recently been reinstated; (3) it is a new council; or (4) the council is not on the Supreme Council's Group Exemption List (updated continually by the Knights of Columbus Legal Department). If you are unable to e-file, please contact the Legal Department by email at tax.ein@kofc.org. You can also contact the IRS customer service at **1-877-829-5500**.

Compliance Guide for Tax Exempt Organizations

In addition to the annual filing requirement, each council is responsible for conducting its affairs in a manner that is consistent with what is expected of tax-exempt organizations. Failure to do so may result in a council losing its tax-exempt status. In this regard, councils may wish to consult an IRS publication entitled *Compliance Guide for Tax Exempt Organizations*, which provides helpful guidance:



SUPREME CHAPLAIN'S MONTHLY CHALLENGE

April 2025

She said to him, “Yes, Lord. I have come to believe that you are the Messiah, the Son of God, the one who is coming into the world.” (Gospel for April 6, Jn 11:27)

These words belong to Martha, sister of Lazarus, as she and Jesus speak outside her brother's tomb. Her choice of words is important: “I have come to believe.” This suggests her belief has evolved, that her previous uncertainty or ignorance about Jesus has blossomed into faith. Growing in faith is usually a process of moving from questioning or doubt to illumination and trust. How do we come to faith and then grow deeper in it? We do so through prayer, study and reflection. Let us continually deepen our faith in this manner.

Challenge by Supreme Chaplain Archbishop William E. Lori:

This month, I challenge you to take part in a Catholic faith formation course, event or opportunity offered through your local council (such as *Cor*), your parish or diocese, or online.

Questions for Reflection:

Looking at the development of your own faith, how have you “come to believe” truths about Christ and/or the Catholic faith? What teachings do you still have questions about? What areas of your faith would you like to develop further? Where can you find resources — or whom can you ask for resources — to help you deepen your faith and understanding?

FAITH IN ACTION PROGRAMS

HOLY HOUR

Organize a regular Holy Hour or host a Eucharistic Procession.

A HIGHER PURPOSE

Encourage deep personal encounters with Christ through Eucharistic adoration in the form of Holy Hours and Eucharistic Processions. As Catholics, we believe in the Real Presence: that Jesus Christ is truly present – body, blood, soul, and divinity – in the Eucharist. As such, we are compelled to grow in our devotion to Jesus in the Eucharist and to share His presence with the world.

OVERVIEW

Holy Hours feature the exposition and benediction of the Blessed Sacrament and can also include a reflection, communal rosary, prayers for intercession by Blessed Michael McGivney or St. Joseph, and other devotions as decided by the council and pastor. Eucharistic Processions provide an opportunity to walk with the Blessed Sacrament through your community, bringing Jesus to everyone along the route.

As the sainthood process for Blessed Father Michael McGivney continues, it becomes ever more important to increase membership in the Father McGivney Guild. Membership stands at over 171,000, but only 464 listed to be from Wyoming. There are 2600 members shown in Wyoming.
